Detailed magnetotelluric (MT) survey planned following encouraging results from existing Olympic Domain Magnetotelluric survey near the Horse Well Project area

Highlights:

- Existing Olympic Domain Magnetotelluric (MT) survey results (DEM SA and Geoscience Australia) indicative of a deep basement conductive zone (“feeder zone”).
- Detailed Magnetotelluric (MT) survey approved for the Horse Well Project to further delineate conductive zone and its association with current magnetic and gravity targets.

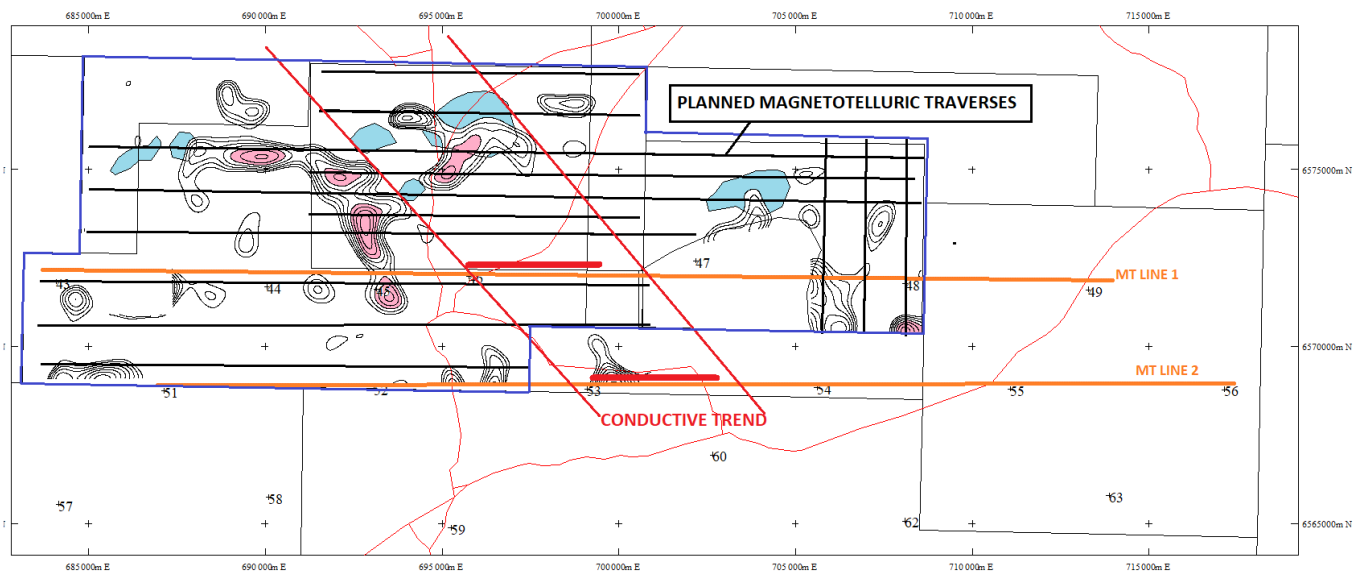


Figure 1: Magnetotelluric (MT) traverses (black lines) planned for the Horse Well Project area (blue outlines). Magnetotelluric (MT) traverses conducted by DEM and Geoscience Australia shown in orange.

Cohiba Minerals Limited (‘Cohiba’ or ‘the Company’) is pleased to announce that further to the five (5) exploration targets identified within the Horse Well Project area (see Announcement January 22, 2019) it has assessed existing magnetotelluric (MT) survey data from Geoscience Australia and determined that further detailed magnetotelluric (MT) work is warranted (Figure 1).

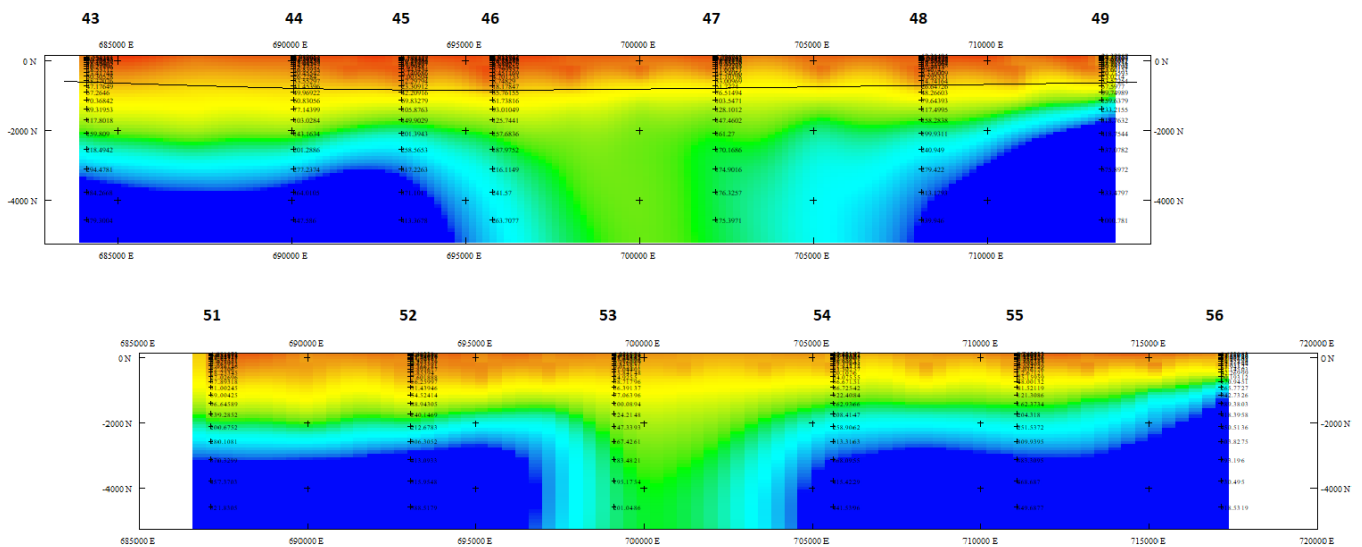


Figure 2: Magnetotelluric (MT) sections across part of the Horse Well Project area showing potential conductive zone at depth. These sections correspond to MT LINE 1 (top section) and MT Line 2 (bottom section) in Figure 1 above.

The magnetotelluric (MT) survey work undertaken by DEM SA and Geoscience Australia which passed through the southern portion of the Horse Well project area (MT LINE 1 – Figure 1). The results from this line imply that a deep basement conductive zone occurs in the area., Previous magnetotellurics surveys in the region have suggested that such conductive zones may reflect deformation zones and fluid pathways (Figure 2). These “feeder” zones are interpreted to coincide with the highly prospective iron oxide copper gold (IOCG) belt that connects to a mantle plumbing system.

Given that MT LINE 2 (Figure 1) is not within the Company’s tenements and detailed MT information closer to the exploration targets was not available, the Company will conduct detailed MT on closer spaced lines over the Horse Well project area to enhance the definition of exploration targets within the Horse Well Project area.

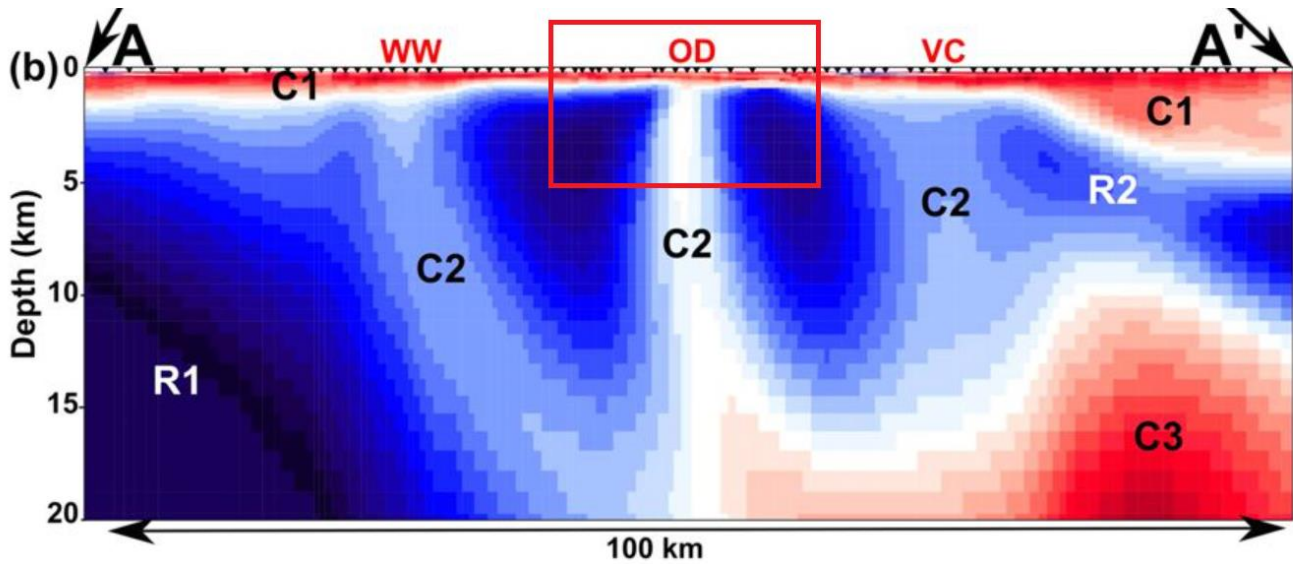


Figure 3: Magnetotelluric (MT) section across the Olympic Dam (OD) deposit (from Geoscience Australia) showing major conductive zone (“feeder”) in white. The red rectangle shows the approximate size of the equivalent cross-sections in Figure 2 for comparative purposes.

Magnetotellurics (MT) conducted over the Olympic Dam area as part of Geoscience Australia’s national initiative showed a major conductive zone or “feeder” system associated with the deposit, as shown in Figure 3. The MT data close to the Horse Well (Figure 2) area is highly encouraging given the results of the Olympic Dam survey, and further reinforces the merits behind the approved works program.

Cohiba’s Executive Director Mordechai Benedikt, said, “the Company is very pleased to be able to undertake this detailed magnetotelluric survey to enhance our knowledge of these conductive zones, and suggest potential feeder systems that are intimately associated with IOCG deposits.”
